## Competition Information

- **No bench duty required, 20-minute running clock per half.**
- **Teams playing semi-final rounds will pay their match fee on the day. Grand finals are free of charge.**
- If you forfeit a match, your team must pay a reimbursement to FDLC for the opposing team's match fee (\$120).
- Teams will not be permitted to play future matches until forfeit fees are paid.
- Teams who forfeit 3 times may be removed from the competition at management's discretion.
- All prices, dates and times are subject to change. Teams will be notified immediately through contact details provided.
- **Match Times:** 6:40pm – 10:00pm (Estimated).
- **Team Nomination Fee:** \$30 (To be paid upon submitting this form)
- **Team Season Fee:** \$2160 (\$120 per game)
- **Individual Player Registration:** \$87.50 (Expires June 30, 2023 – Allows players to register for two (2) successive competitions (Spring + Summer Competition)).
- **Total Fees:** \$2190 + \$87.50 Individual Player Registration.
- **Number of Rounds:** 18 Rounds + Semi-Finals + Grand Final
